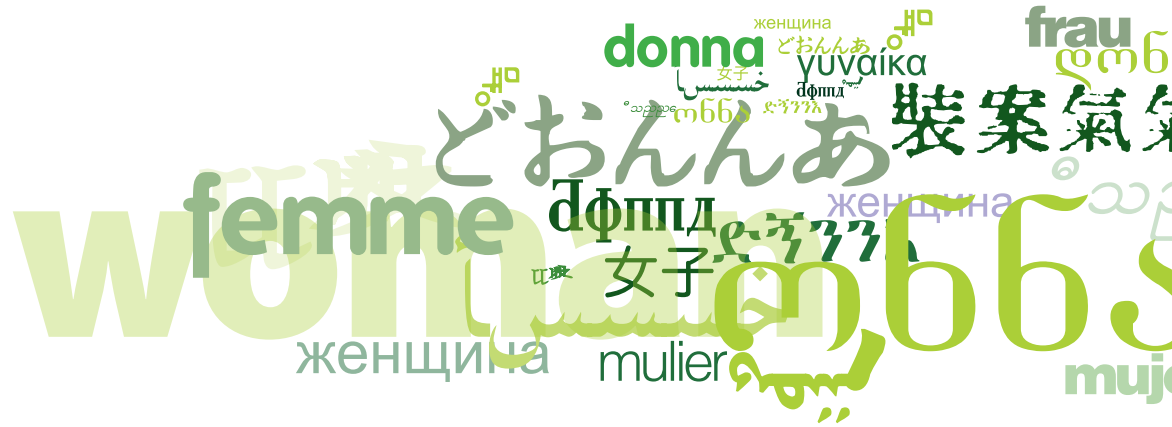

### **Information on the processing of personal data pursuant to art. 13 Of eu regulation 2016/679 and of the legislative decree 196/2003.**

Pursuant to Article 13 of the EU Regulation 2016/679 GDPR "General Data Protection Regulation" and to the Legislative Decree 30 June 2003, no. 196 "Code regarding the protection of personal data", the Regional Council, in charge of processing personal data, is required to provide information on the use of your personal data.

The collection of your personal data, including any photographs / films produced in support of your application, is carried out by the General Affairs Office - Cultural Activities and Ceremonial Office of the Regional Council, recording the data you provided when submitting your application or with subsequent communications. The contribution of data is optional, however the denial to supply said data may lead to the failure to accept the application to the "Woman of the Year" award.

At any time you can ask the office in charge of processing personal data access, rectification, cancellation of your personal data or the limitation/opposition to the processing, and you can propose a claim to the Guarantor for the protection of personal data.
